In the Governor's Press release found at the link below, the Governor is crediting his Design–Build Initiative as a savings to taxpayers. As you know, the Design-Build process is one wherein the State contracts out for services typically provided by PEF members. WE, the S/W L/M team have confirmed that some of these projects cited in the Governor's Press Release were in fact 100% designed by PEF members. The Governor should not be permitted to credit private contractors, and himself, for work performed by PEF members without a response from PEF.

For example:

Regarding the Press Release cited Patterson Bridge project, this Bridge was designed by PEF members in the Main Office's Structures Unit, and PEF members in Main Office Design Services Bureau designed the Highway Component, & PEF members here in Region 6 worked on the Erosion Control component. Also, a PEF member has been assigned as EIC, Engineer in Charge, and he has 2 PEF members assigned to perform the Construction Inspection on the Patterson Bridge project.
