# NYT: Use of Federal Contractors Result in Delays, Overruns, and Unmet Public Needs

The *New York Times* recently editorialized against the "increasing extent" in which (federal) government work has been contracted out to private-sector companies. Currently, according to the *New York Times*, the federal government spends about \$500 million a year on private sector contracts, more than twice the amount spent in 2000. While conceding that it is legitimate to outsource when the government does not have the expertise for a certain task, the *New York Times* questions the "current practice of contracting out vast swaths of government work indefinitely – with little or no attempt to develop the needed technical and managerial expertise within the government or to enforce labor standards – [which] has

created a bloated federal-contractor sector in which the public good is often subservient to profit."

## Availability Payments Shift P3 Risk Back to Taxpayers

In light of the many Public-Private Partnerships (P3) where overly optimistic traffic projections caused toll roads to struggle and fail financially, P3 investors are pressuring states to pay regular guaranteed payments in lieu of keeping toll revenue. MAP-21, the current transportation authorization, formalized the approval of availability payments, which can be funded through tolls and/or a state's transportation budget, as an acceptable mechanism to finance P3 transportation projects.

But as this <u>recent Bloomberg article</u> shows, Congressional approval does not necessarily translate to being a good deal for taxpayers. The article explores P3 deals in Illinois, Indiana, and Florida where the use of availability payments is "decreasing the risk for [private] operators" and transferring the risk to taxpayers because while projected toll revenue should fund the guaranteed payouts, the state may "have to augment it with money from their operating budgets should traffic fail to generate enough to cover costs."
